An Indigenous Person in Prison

Hi, my name is Stewie, and I am an indigenous addict.

At 11 years of age, I drank alcohol for the first time. My family often had BBQs, so I drank the half-empty bottles or glasses. I remember liking the way it felt.

Growing up I suffered all sorts of abuse from my stepfather, physical and mental abuse. I started smoking pot and sniffing all sorts of stuff.

With the pot, pills, plus booze, came crime and I became violent myself. By now I was free to do whatever I wanted as I was running away from home.

It didn't take long before ending up in a boys' home and then on release, my drinking and drugging progressed. My I received an 18-year sentence.

In prison I was introduced to the needle at first speed, and then heroin for the next 15+ years. Used and abused every drug I could get my hands on. I have used violence to get drugs.

2 years ago, I was introduced to NA. I went to my first meeting for all the wrong reasons hoping it would help with my parole. Pretending I was doing something



about my drug problem. I didn't stop using but the message began to get through. I am the only one who stayed clean. Then I stayed on to carry the message again and again. I was the only person to remain drug-free. I learned to work the steps, I have a sponsor and by the grace of God I am one year clean today. Today I am a violence peaked. I ended up in court where mentor in the Unit that gave me my life back. I try to help the addict who still suffers, and I am so grateful to NA and its members who come into the prison to carry the message. I heard outside guests speak and I wanted what they had. Tried to do it my way but couldn't stay clean. Then the prison started a drug intervention unit. I was ready and had an open mind. 29 of us began our journey and after 14 weeks.

Helping an Addict to Another

My name is Mohammad and I'm an addict.

I will never forget the last time I used drugs. I was using and crying at the same time. My drug use led to the loss of one leg. Endured a lot of pain till I was given the NA message, fortunately.



When released from the detox center, I was full

of pain, hate, resentment and disappointment. Headed to a meeting, and getting in a taxi, despair took over my whole being. On my cellphone, I listened to a voice message my recovery friend had sent me. As soon as I played it, I heard, "In the name of God, I am Parvaneh an addict".

I didn't know who she was or where she is now. I haven't heard anything else about that file. There exploded a bomb of positive energy and hope, into my heart. I took a turn in life and decided to stay clean through the NA meetings, as much as I can and by the grace of God I could!

I began to do service as the H&I and PR chair to pay my debt as one of the Narcotics Anonymous members, and to carry the NA message to the still suffering addicts.

While writing this letter, I have been clean for 6 years, 8 months, and 12 days and I owe my clean time to God and NA.

With or Without My Children

Hi, my name is Jayne, and I am an addict. The first time I said these words was at a Narcotics Anonymous meeting on May 24th, 2004, which was also my first day in rehab. I initially had mixed feelings about Narcotics Anonymous, I didn't feel very comfortable with the members being so welcoming, but I also desired it. I wanted people to be kind to me, but at the same time, repelled by their kindness.

My addiction had taken a big toll on me, so much so that I had to re-learn the absolute basics of life such as old daughter had been forced to her first child and was living with showering and brushing my teeth and hair each day. I also had to learn how to communicate with others. I lost the ability to have basic conversations with people, I was so lonely but also so uncomfortable around others. I was so full of shame and guilt that I often wore a hood in an attempt to hide my eyes. Believing if people could see into my eyes, they would see all the bad things I had done.

My main shame and guilt were around losing custody of my three children four years previously and because of this, I was convinced I was the worst person in the world. Their father took custody of them because as my addiction progressed, I could no longer take care of them, and my fourteen-year-

There was a five-year period when one of my children was estranged from me, but I kept praying and letting go regardless of the pain I was in. I am so grateful for the members who propped me up and fed me hope that one day I would have all three children back in my life. Today, through this program, I have all three children in my life. I have also been blessed with seven grandchildren who know me for who I am today. My most memorable moment so far was Christmas 2020, when I had Christmas lunch with my three children for the first time since 1998. This had been my biggest dream for such a long time and through continuing contact with my Higher Power, it became my reality. What made it even more special was that my seven grandchildren also surrounded me with love that day. I am so grateful that I made the decision to stay clean with or without my children, because Just for Today I have my children and so much more.

Brought Back to Life

My name is Zaidi, I am an addict. My place of residence is in Kuala Lumpur, Malaysia. The reason why I love NA so much is because it has given a special gift that every addict craves, which is to stop and calm down from using drugs. As a child, it can be said that I was a lucky child because I was given enough love from my family. And when I was a child, I



also sat with my grandfather who spoiled me with money. When I grew older, I followed the activities of my uncle and aunt, which was to use drugs. At that moment I felt great when smoking drugs. Until one day I suddenly realized that institutions and prisons were my second home. At that time, I felt that I really had no hope of stopping using drugs and would either die in prison or an institution.

But I am grateful, for having gone from an addict who had given up hope and was gripped by drugs, to having met a program whose message is hope and whose promise is freedom, which is the essence of the NA program. This is where a very strange episode in my life began, which is living a life without using drugs. In NA it was suggested to come again and again, get a Sponsor immediately, and work on the NA program. Going from being a stubborn person to following what NA says, I came again and again, got a Sponsor immediately, and worked on the NA Program. From a stubborn person who does not want to listen, I have trusted someone in NA who is my Sponsor. I followed many things he said, from small things to big things.

It was also suggested to me to do the 12 steps of NA with my sponsor, do service work, carry the message to the addicts who are still struggling and so on. At the beginning of my recovery, I did a lot of service work such as setting the table/chairs, removing cigarette butts, opening the meeting room door, and a few other things. It really helps me in my daily life to be a productive member of society.

In NA there are 2 big things that I can't forget when I hear words from my sponsor, namely:

- 1) My sponsor said that if my recovery age is not yet 2 years old, don't try to get married. I followed and thankfully finally now I have become a father of a pair of children.
- 2) The sponsor said that if my work burdens me, it's better to stop. This I also followed. Even though I will be married in the next month, thanks to my Highest Power and thanks to NA because now I still have work to live life in the true sense of life.

Finally, I am very grateful to my Higher Power for always making it easy for me to come to NA meetings so that I can stay clean from using drugs until today.

Mati Hidup Semula

Nama saya Zaidi, saya seorang penagih. Tempat permainan Asaya adalah di Kuala Lumpur, Malaysia. Mengapa saya sangat sangat sayang dengan NA adalah kerana ia telah memberi suatu hadiah yang istimewa yang didambarkan oleh setiap orang penangih iaitu berhenti dan tenang dari mengguna



dadah. Semasa kecil boleh dikatakan saya seorang kanak-kanak yang bertuah kerana diberikan kasih sayang yang cukup dari keluarga saya. Dan semasa kecil juga saya duduk bersama datuk yang mana mereka sangat manjakan saya dengan wang ringgit. Bila usia meningkat remaja saya terikut-ikut dengan aktiviti pakcik dan makcik saya iaitu mengguna dadah. Pada ketika itu saya rasakan hebat bila menghisap dadah. Sehinggalah suatu masa tiba-tiba saya tersedar yang institutsi dan penjara adalah rumah kedua bagi saya. Waktu itu saya rasakan bahawa saya memang tiada harapan untuk berhenti mengguna dadah dan akan mati didalam penjara atau institusi.

Akan tetapi saya bersyukur dari seorang penagih yang telah putus harapan dan masih dicengkam oleh dadah saya telah bertemu dengan satu program yang mesejnya adalah harapan dan janjinya adalah kebebasan iaitu NA dalam suatu program besar yang mereka anjurkan. Disinilah episod yang sangat asing dalam hidup saya bermula iaitu menjalani kehidupan tanpa mengguna dadah. Dalam NA saya disarankan untuk datang lagi dan datang lagi, mendapatkan Sponsor dan kerjakan program NA. Dari seorang yang keras kepala saya ikutkan apa kata NA, saya datang lagi dan datang lagi, mendapatkan Sponsor dengan segera dan kerjakan Program NA. Dari seorang yang keras kepala tidak mahu dengar kata, saya telah mempercayai seseorang dalam NA iaitu Sponsor saya. Saya ikut banyak perkara yang dikatakannya, dari perkara yang kecil hingga ke perkara yang besar.

Saya juga disarankan untuk kerjakan 12 langkah NA bersama sponsor, buat kerja-kerja servis, sampaikan pesanan kepada penagih-penagih yang masih sensara menagih dan lain-lain lagi. Diawal pemulihan banyak kerja-kerja servis yang saya lakukan antaranya atur meja/kerusi, buang puntung rokok, buka pintu bilik perjumpaan dan beberapa perkara lain. Ianya sangat membantu saya dalam kehidupan seharian untuk menjadi ahli masyarakat yang produktif.

Dalam NA ada 2 perkara besar yang tidak dapat saya lupakan apabila mendengar kata dari sponsor saya iaitu:

1)Sponsor saya kata jika usia pemulihan saya belum sampai 2tahun jangan cuba-cuba untuk berumahtangga, saya ikut dan syukur sehingga kini saya telah menjadi seorang bapa kepada sepasang anak

2)Kata sponsor jika kerja saya membebankan lebih baik berhenti saja dan ini pun saya turuti juga walaupun saya akan berumahtangga dalam masa sebulan yang mendatang, syukur kepada kuasa tertinggi dan terima kasih kepada NA kerana sekarang saya masih ada bekerja untuk menjalani kehidupan dalam erti kata hidup yang sebenar.

Akhir kalam, saya sangat bersyukur kepada kuasa tertinggi kerana sentiasa permudahkan saya datang ke perjumpaan NA untuk saya kekal bersih dan tenang dari mengguna dadah sehingga ke hari ini.

And the Drug Policy Program sees NA as one solution to refer addicts who are still using so they can recover from addiction.


Friday, July 19, 2024

NA (PR Coordinator, FD Coordinator, WFD Coordinator, and 6 NA Malaysia members) attended a meeting at the Drug Policy Program office to prepare for a meeting with professionals the next day. In this meeting, we first explained what NA is and how this program runs and works for all of us.

Saturday, July 20 2024 (8.30 am - 5 pm)

This event was attended by around 30 professionals from various organizations and individuals who work closely with addicts, including psychologists, rehabilitation professionals, NGOs, and Islamic religious leaders.

This event was more of a workshop specifically explaining NA, questions and answers, we also mock demonstrated NA meetings. All participants were very enthusiastic during this presentation/interaction. From the start we were informed that in Malaysia NA is known as




We explained in detail the 12 steps, steps 1 – 12 with specific examples.




